

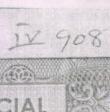

- 2. Registered Office: The Registered office of the Trust shall be situated at- Jamuar Kothi, Shahid Road, Po- HPO, PS-Kotwali, Dist-Gaya.
- 3. Area of Operation:-The area of operation shall be whole India.
- 4. AIMS & Objects:- (a) (i) To run and manage educational institutions at present:-
 - (ii) To run various courses in the field of general and vocational education and to carry out research projects in social and economic field assigned by government and private agencies.
- (a) To remove illiteracy from urban as well as rural areas.

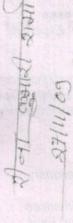

RULES & REGULATION

OF

DEFINATION:

(a) Trust Means

CHANKYALDUCATIONALTRUST

(b) Office Bearer Means

: Chairman, Secretary &

Treasurer

(c) Committee means

: The Managing Committee

: From 1st April to 31st

March

2. MEMBERSHIP

Membership shall be open to all irrespective of caste and creed which are not less than 18th Years of age, Membership shall be opened to all and shall consist of the following class:-

(a) LIFE MEMBERS:-

Life Members means the persons who have contribute Rs 21000/- in cash or kind

(b) FOUNDER MEMBERS :-

Founder Members means the promoters whose names and subscribed in Memorandum of trust and such other members as may be admitted from time to time by the majority of the General Body Meeting.

(c) ORDINARY MEMBERS:-

Ordinary Members means the person who have paid or pay Rs 501.00 as their admission fee and who have agreed to pay Rs 151/- every years as subscription on or before 31st March

(d) HONORARY MEMBERS:

Honorary Mmebers means persons of distinction in

public life vocatin or trade who may be invited by the institution to become its members for such period as determined by the committee from time to time. Such person shall be deemed to be honorary members from the date of his acceptance of the committee's invitation.

- 3. Apllication For Admission:
- (a) Every application for the admission as member of the trust shall be addressed to the secretary of the trust.
- (b) No application shall be considered unless the applicant is proposed by a Founder member & seconded by another such member.
- (c) Every such application shall be considered in the meeting of the Managing Committee and shall be accepted or rejected by a vote of majority save as those filling under Rule-4 of these rules.
- (d) Every application shall be informed in writing by the secretary of the decision of the Managing Committee which shall be final.
- 4. TERMINATION OF THE MEMBERSHIP
- (a) By failing the payment of his annual membership fee with out reasonable ground.
- (b) By resignation
- (c) By failing to attend three meeting without information continuously
- (d) By death, or by unsound mind
- (e) By order of the secretary in consultation with the chairman if any member will not abide with the Rules of the trust or if found guilty of misconduct
- 5. FUNCTION OF MANAGING COMMITTEE:
- (a) Subject to the provision of these rules, the affairs of the Institution shall be administered and controlled by a managing Committee and shall be comprise of seven (7) members including office bearers elected by the General Body for a period of 3 years.

कीना कुभक् श्रमण ०१ (b) The members of the Managing Committee shall continue as such for a period of 3 years. Vacancy created by death or otherwise, shall be filled in withing 3 months of the occurrence of such vacancies.

6. POWER & FUNCTION OF THE MANAGING COMMITTEE:

The functions of power of the Managing committee shall be as follows:-

- a) To carry out the aims and objects of the trust.
- b) To administer and control the affairs and funds of the trust and exercise all powers of the trust.
- c) To do all other lawful acts, matters, things and deeds as may be conducive to and expedient in interest of the trust.
- d) To purchase, take on lease or in exchange or hire or otherwise acquire any moveable or immoveable property for the purpose of the trust and to carry out agreement, contract obligations and arrangements on suitable terms.
- To manage all the institutions conducted by the trust.
- f) All important matters will be discussed at first in the meeting of the managing committed and if absence of managing committee, chairman & secretary will empowered to take any decision with both discussions.

GENERAL BODY MELTING:

The General body meeting of the trust will be attended by all the members. The first Gereral Body Meeting of the trust shall be held within six months of the expiry of the Financial year, In which the first General Body Meeting was held, Thereafter the annual General Body Meeting of the trust shall be held with eighteen months from the date trust shall be head within eighteen months from the date of its registration under societies Registration Act, 21 of 1860.

8. PROCEEDING OF THE ANNUAL GENERAL BODY MEETING:

- a) Prosing the Accounts of the previous Financial Year.
- b) Election of office bearers and the members of the Managing Committee to fill the vacancies caused by the retirement of otherwise.
- c) Appointment of Auditor for the next year.
- d) To receive and adopt the annual report, the statement or accounts for the proceeding year and the financial budget estimate for the ensuing year.
- e) To consider any other matter deemed important by the Chairman or the majority of the members present at a General Body Meeting 1/3rd person shall form a Quorum. If the Quorum is not present within half an hour of the fixed time, the meeting shall be adjourned to the same date and time and at the same place for the next week and if the quorum is not present at the adjourned meeting too, the members present shall be deemed to form quorum.

The Notice of the General Body Meeting shall contain items of business to be transacted and with mention of place and time shall be issued to all members at least 15th days before the Meeting.

The notice of the Annual General Body Meeting shall contain the items of business to be transacted at the meeting and shall mention the place and time of the meeting. The notice of the Annual General Body Meeting shall be given at least four days before the Meeting.

The Notice of the Managing Committe shall contain items of business to be transacted and with mention of place and time shall be issued to all members at least 15 days before the Meeting.

The notice of the Annual General Body Meeting shall contain the items of business to be transacted at the meeting and shall mention the place and time of the meeting. The notice of the Annul Gereral Body meeting shall be given at least four days before the Meeting.

The notice of the Managing Committee shall contain items of business to be transactd and with mention of place and time shall be issued to all members at least 15days before the Meeting.

The managing committee shall be held at least in quarterly at such time and place as fixed by th Secretary, and emergent managing committee meeting (shall be held at any time of the trust by the notice of 48 hours before.

GENERAL BODY

The Chairman shall reside and in his absence the secretary shall preside in addition to his duties. The Annual General Body meeting shall be held at least once in a year at such time and place as fixed by the Seccretary.

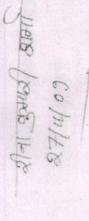
Power & Function of the office Bearers

Chairman

The Chairman shall reside at all meeting of the managing committee and of the trust when he is present and shall exercise suhc other powers as are conferred upon him by these rules. The Chairman that a resolution has been carried or lost shall be conclusive. Unless such a declaration is challenged and poll is demanded on poll, being demanded the same shall be taken in such a manner as the president may in discretion determine, In case of a tie, the chirman shall have a second or casting vote. The chairman may call for an emergent meeting at a shorter notice.

Secretary

- a) He shall be in charege of the office and shall be responsible to general body in all metters. He shall contract and all ways and means of the position of the association & shall have right to improve it.
- b) He shall be convener of all the meetings.
- c) It shall be his duty to see that the resolution at respective meeting are implemented and give to effect timely.





- d) He shall be at liberty to expend for the purpose of the trust without sanction of the managing committee. To do all such other lawful notes, deeds or things as incidental or conductive to the attachment of trust.
- e) He shall maintain the account in proper and prescribed form. He shall deposit and with draw the amount of the trust in the Bank or in the post office with the Singnature of secretary & Treasurer jointly.
- He shall produce the accounts of the trust before the Managing Committee.
- g) He will produce the expenditure of the trust before Managing Committee for approval.
- h) He shall appoint suspend, discharge, fix the salary, make payment of the employees of the institution conducted by the trust on behalf of the managing Committee but in consultaition with the Chairman.

TREASURER

- a) The Treasurer will act under the direction of the Committee.
- b) Any amount exceeding Rs. 5000/- which in not required for immediate use shall be paid into such bank or banks as may be approved or by the Committee.
- c) The Treasurer shall ordinarily receive shall payments and disburse the amount passed by the secretary and all maintain proper books of accounts.

11. BANK OPERATION

The Account of the trust shall be kept properly and the Bank Account will open in a Nationallized Bank of post office by the Name of the trust and it will be operated by secretary & treasurer jointly only.
